Fee Charging Policy – Learners/Employers

This Policy statement is in reference to payment by the Learner/Employer of charges, relating to the cost of services provided by FW Solutions Ltd.

Course Fees:

- The Directors of FW Solutions Ltd set the fees for each course offered and these are reviewed on an annual basis but are also subject to a change in funding circumstances and government legislation.
- The fee for each student is determined by the subject, the course, the mode of study the number of academic credits that can be achieved and the student's fee status.
- During a Learners Initial Sign up, students will be given information with regards to fees and how this can be funded. The exact fee and source of funding will be confirmed in a letter once they are registered.

 5. Students (24+ Loans – Student Loans Company)
- **Payment of Fees and Charges**

Unless otherwise stated, learners who are funding their own study must pay their fees as agreed with the FW Solutions Ltd representative at their initial sign up meeting. Applications for funding to cover the cost of tuition fees will be applied for following the initial sign up meeting. Tuition will not commence until this funding has been confirmed with the appropriate source.

Learners who are subject to the 24+ Loan criteria will need to complete the appropriate paperwork and submit to the loan provider in a timely manner. The loan company should provide information of acceptance within a published timescale. The Student Loans Company will pay your fees directly to FW Solutions Ltd.

All guidance regarding 24+ Loans is provided after consultation with all relevant documentation issued by the Student Loan Company (SLC) and any discrepancies or questions not covered by the 'frequently asked questions' resources will be referred back to the SLC for clarification.
